Sir,

Please refer to your letter dated 18-11-2008 on the above cited subject.

In this regard, I am to inform you that permission is granted to open new primary school, Class-Ist in English Medium unaided (without any Government grants) from the academic year 2009-2010 at Fr Agnel Central (CBSE) School, Tiswadi Pilar- Goa, as per Rule 31(3) of the Goa School Education Rules, 1986 subject to the fulfillment of all the conditions laid down in Chapter III and also compliance of all other provisions stipulated in the Goa School Education Act, 1984 and the Goa School Education Rules, 1986 and the instructions issued by Director of Education/Government from time to time and subject to the following conditions:-

1. Before commencing with the said standard, the Management should report the arrangement for providing suitable accommodation, necessary furniture and other equipments, the arrangement made/proposed to be made for providing the necessary staff to Dy. Education officer concerned and only when he is satisfied with the said arrangement, the class should start functioning otherwise the permission granted shall automatically stands cancelled.
2. Facilities for drinking water, sanitation, language teaching, History and Geography teaching, Science teaching, Sports and Games etc. shall be made available.
3. No further permission will be granted to change the medium of instruction.
4. Trained teachers with adequate qualification should be appointed.

5. The teaching and non-teaching staff should be paid their salaries by cross cheques, on par with their counterparts in Government/Government Aided School and they shall be made admissible for all service and retirement benefits.
6. The School Managing Committee should be constituted as per Rule 46 of the Goa School Education Rules, 1986
7. The School shall admit a maximum 25 students. They have to continue with their own Pre-Primary students and not to admit the students of nearby schools.
8. The school shall file statement of fees to be charges every year in the month of May/June for the approval of Directorate of Education without fail.

This is only permission for starting class and not recognition for the said class. Recognition of the school is governed by the provision of Rule 36 of the Goa School Education Rules, 1986. The same is required to be obtained by submitting the application form-I under said Rule 36 immediately after opening of class.






